The retirement provisions for former governors are determined pursuant to the Governors' Pensions Act 1976.

The act provides for the Treasurer to make a determination of the pension to be paid to a former governor. Advice is taken from Super SA in reaching this determination. No annual provision is made in the State Governor's Establishment budget for this liability.

MINING ROYALTIES

In reply to Mr HAMILTON-SMITH (Waite—Leader of the Opposition) (25 June 2008).

The Hon. M.D. RANN (Ramsay—Premier, Minister for Economic Development, Minister for Social Inclusion, Minister for the Arts, Minister for Sustainability and Climate Change): The Minister for Mineral Resource Development has provided the following information:

Budget paper 3, page 3.24 provides royalty revenue projections for mining, oil and gas production for the next four years to 2011-12—these are \$163.5 million in 2008-09, \$183.8 million in 2009-10, \$185.5 million in 2010-11 and \$193.8 million in 2011-12.

Royalties from the proposed expansion of the Olympic Dam mine have not been factored into the budget papers as it is still in pre-feasibility stage and to have done so would have been improper. Furthermore, the proposed expansion of the Olympic Dam mine would not commence generating additional royalty revenue within the forward estimate period and would take some years to become operational and then to reach full production.

The overall budgetary impact of increased capacity to generate royalty revenue will be affected by the Commonwealth Grants Commission's assessment of state and territory fiscal needs which determine GST revenue shares.

The fiscal equalisation process will redistribute a significant component of additional royalty revenue-raising capacity generated in South Australia to other states and territories through the distribution of GST grants. Similarly, growth in royalty revenue-raising capacity from mining expansions in other jurisdictions will be redistributed to the benefit of South Australia.

Forecasts for mining royalties are reviewed on a regular basis, and the budget numbers reflect the latest estimates. As the Premier indicated, royalties are not received until the mines actually open, and we will continue to provide updated royalty projections within the government's five year forward estimate period.

The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations): I have been provided the following information:

The member's question relates to shared services and other savings measures announced in the 2006-07 budget, which were to come into effect progressively over the period 2006-07 to 2009-10.

The impact of the 2006-07 savings measures, along with the further impacts of both expenditure and savings initiatives contained in subsequent budgets, have been built into the forward estimates and as such are included in FTE cap numbers.

No targeted voluntary separation packages (TVSP) have been offered in the period since the 2006-07 budget. As a consequence any FTE reductions resulting from the 2006-07 budget savings measures will have been met through either natural attrition or redeployment to other areas of need within the public service.

PUBLIC SECTOR EMPLOYEE NUMBERS

The 1,991 FTEs referred to in the member's question relates to the difference between the governments estimate of total public sector employment as at 30 June 2008 reported in the 2007-08 and 2008-09 budgets.

The majority of the variation between the two estimates (1,758 FTEs) relates to the general government sector, which is covered by the government's FTE cap. The FTE cap is adjusted for cabinet decisions made throughout the year, as well as 2008-09 Budget initiatives.

Since the time of the 2007-08 Budget, additional funding and FTEs for the year ending 30 June 2008 have been approved for education, families and communities, health and justice to assist in meeting the demand for services in these portfolios.

In addition, an adjustment was made to the cap for the Department of Education and Children's Services to rectify a specification error in the original cap.

PUBLIC SERVICE EMPLOYEES

The Department of Water, Land and Biodiversity Conservation is forecasting a net surplus of \$13.4 million for the Save the River Murray Fund as at 30 June 2008. The majority of these

funds are committed to South Australia's contribution of \$65 million to address over-allocation of water in the Murray-Darling Basin, as part of the 2003 Living Murray Intergovernmental Agreement.

South Australia has a commitment to five interstate investments under the Living Murray Initiative Water Recovery Program, with the majority of the milestone payments totalling \$22.8 million due for payment in 2008-09.

SOUTHERN STATE SUPERANNUATION SCHEME

In reply to Mr HAMILTON-SMITH (Waite—Leader of the Opposition) (25 June 2008).

The administration fees charged by Super SA are currently \$52 per year on each Triple S account. Funds SA deducts an investment management fee prior to declaring investment returns, based on the investment option selected.

The South Australian Government Financing Authority (SAFA) has no direct exposure to the US subprime mortgage market.

SAFA has a range of very highly rated financial assets, including in its cash management products. These include AAA Australian residential mortgage backed securities, longer dated highly rated senior bank floating rate notes and insurance related investments. While these financial assets have suffered adverse market value movements as credit spreads have widened, it has not impacted on the state's liquidity position.

SAFA's insurance related investments are managed by Funds SA.

Funds SA does have holdings of mortgage backed securities which include some indirect subprime exposure. The exposure represents approximately 0.006 per cent of total funds under management.

The South Australian Government Financing Authority (SAFA) uses derivatives as part of its fundraising and asset and liability management activities to lower funding costs; facilitate diversification of funding sources; reconfigure interest rate risk profiles consistent with debt management strategy; and convert foreign currency exposures into Australian dollars.

The main derivative instruments used by SAFA are Australian dollar interest rate swaps that are used to manage Australian interest rate risk. Foreign currency derivatives are used to manage foreign exchange risk.

SAFA undertakes derivative transactions with approved creditworthy Australian and offshore financial institutions. All of SAFA's derivatives are on balance sheet.

Information on derivative instruments used by SAFA is included in the disclosure notes to SAFA's annual financial statements.

Interest rate risk limits apply for all portfolios managed by SAFA.

Where the portfolio is managed on behalf of a client, the limits are set by the client.

The limits for portfolios residing on SAFA's balance sheet are endorsed by the SAFA Advisory Board and approved by the Under Treasurer and Treasurer.

The key portfolio on SAFA's balance sheet used to fund loans to clients holds liabilities, assets and hedging instruments (including derivatives) and is run on a basis where mismatches between assets and liabilities are managed within tight risk parameters as shown in the table below.

The Motor Accident Commission's sole recovery provider is Australian Credit Management (ACM).

The decision to select ACM in July 2006 was not made on the basis of cost savings or extra collections alone. Also considered was the improved service provision model, which will allow for additional collections to be made in the future as a result of better quality information.

Recovery collections are a long-term process and the contract has only been in effect for 22 months. A full review of ACM's performance will be conducted later in this financial year. However, the MAC's Claims Manager reports the service provided by ACM has been an improvement on the previous debt collection service provider. In particular, the on-line services allow accounts to be electronically placed for collection, and comprehensive reporting can be now provided at any time.

The Motor Accident Commission's 2007-08 sponsorship program supports efforts to reduce the incidence and impact of road crashes (and the resultant injuries) on South Australian roads. In addition, sponsorship funding is also directed to rehabilitation and research initiatives to accelerate recovery for road crash victims and improve their quality of life.

The sponsorship commitment for 2007-08 was \$2,459,000. There were around 40 sponsorships that commenced or were implemented during 2007-08. These included:

- 19 Community road safety group project grants across the state, supporting local communities:
- Schoolies festival and Barossa schoolies bus services catering for more than 20,000 school leavers;
- The SA Police road safety education program in more than 700 schools and support for the traffic training and promotions unit in the community;
- The good sports program in regional SA, which is now operating in more than 140 country sport clubs;
- Free public transport for Clipsal 500 ticket holders;
- Free new year's eve transport for South Australians in Adelaide as well as bus services in Victor Harbor and Goolwa;
- Adelaide's after midnight Saturday bus service;
- An interactive road safety display at the National Motor Museum in Birdwood;
- Riverland Youth Theatre's youth-for-youth production, Hoons;
- The Adelaide Bank festival of arts Persian Garden road safety promotions;
- Australasian College of Road Safety lunchtime seminars;
- TRACsa research program to improve the treatment, recovery and quality of life for road crash victims;
- Centre for Automotive Safety research into the causes of road crashes.

Ministers participated in 9 of these visits.

EXPORTS

In reply to Dr McFETRIDGE (Morphett) (26 June 2008).

The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations): I have been provided the following information:

The \$9.5 million spent on international marketing development assisted in generating \$168.25 million in export revenue for South Australia. Put into perspective, for every dollar spent, about \$18 in export benefits was achieved.

It should also be noted that the results from marketing takes place over a period of time and does not occur immediately. As such, the actual export values may be even higher than the number just mentioned.

Because there are so many different factors involved, it is difficult to draw a direct correlation between the international marketing development activities by our overseas offices and new jobs generated in this State.

Export results are as much about job retention for successful exporting firms, as they are about job generation.

I would like to highlight that for the first time, South Australia has crossed the threshold of \$10 billion in merchandise exports. In the 12 months to May 2008, South Australia's merchandise exports were worth \$10.25 billion, up 12 per cent year-on-year.

The 12 per cent growth was the highest in Australia, even overtaking the 10 per cent growth of boom in resource rich Western Australia.

The \$62.425 million included in budget paper 4, volume 1, page 2.7 represents the net cost of all the services provided by the Department of Trade and Economic Development (DTED). The aim of DTED is to work with business and the community to create and retain jobs, maintain a competitive business climate, increase investment, facilitate major projects, encourage innovation and entrepreneurship, promote trade and ensure the development of a highly skilled workforce to meet the needs of business.

In 2007-08 DTED worked with a number of businesses that have committed to investments in excess of \$800 million that will generate more than 2,537 new jobs.

The above investments committed and new jobs that will be generated include:

- \$82 million committed by successful applicants of round 2 of the Innovation and Investment Fund generating 577 new jobs;
- \$211 million committed by successful applicants under the Regional Development Infrastructure Fund generating 468 new jobs;
- \$384 million committed through facilitation by the regional development boards (funded through DTED) generating 627 new jobs; and

\$137 million committed through other investment attraction and case management facilitation generating 865 new jobs.

The cost of participating in the Hong Kong ICT Expo was \$13,562, offset by contributions of \$5,600 by participating organisations.

These costs do not include travel, accommodation and salaries of departmental officers.

MARKET ACCESS PROGRAM

In reply to Dr McFETRIDGE (Morphett) (26 June 2008).

The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations): I have been provided the following information:

The Market Access Program (MAP) has assisted nearly 300 South Australian businesses in 2007-08 to develop export markets.

The budget for this program for 2007-08 was \$1 million.

The TradeStart program, jointly funded by the federal and state government has, in 2007-08, assisted nearly 50 new South Australian exporters to achieve more than \$8 million in export sales.

The net cost of this program for 2007-08 was \$164,000.

The South Australian Government has commercial offices in strategic overseas markets such as China, the European Union, the Middle East, India, Hong Kong and Singapore, providing on-ground support and market intelligence for the state's exporters.

Overseas commercial offices deliver trade outcomes by facilitating strategic relationships with foreign governments and business entities; identifying and developing export opportunities for South Australian exporters; promoting South Australia as an investment, education and migration destination.

In total the overseas network has facilitated nearly \$170 million in exports during 2007-08.

The cost of the commercial offices for 2007-08 was \$2.6 million.

In addition, the government sponsored International Business Week informing exporters in metropolitan and regional South Australia of government export programs, trade policies and export opportunities.

The cost of participating in International Business Week for 2007-08 was \$10,000.

Economic Research Consultants was engaged to provide project assessment services as part of the innovation and investment fund of South Australia. A report has been submitted and the cost of the consultancy is \$6,000.

Ethos was engaged to facilitate the establishment of a planning process for the future direction and development of the economic analysis and planning division. A report has been submitted and the cost of the consultancy is \$3,500.

Enterprising Partnerships Pty Ltd was engaged to advise and document a framework for DTED in preparation for a visit by Mr Petri Kalliokoski (vice-president of innovation at VTT Tech Research Centre of Finland). A report has not been submitted as the consultancy involved bringing to Adelaide this world renowned innovation expert and arranging forums with key personnel only. The cost of the consultancy is \$5,219.

Intellectual Capital Services Ltd was engaged to develop a business model for an economic analysis and planning innovation strategy process. A report has been submitted and the cost of the consultancy is \$20,000.

Dr Michael Keating was engaged to be the lead reviewer of a report commissioned by the Economic Development Board to review South Australia's skills and workforce development system. The review considered the capacity and capability of SA's workforce to respond to anticipated economic opportunities. A report has been submitted and the cost of the consultancy is \$30,068.

GHD Pty Ltd was engaged to review and develop a SA development code aimed at identifying deficiencies in the current SA market and increasing the state's competitiveness internationally. A report has been submitted and the cost of the consultancy is \$65,529.

Botten Levinson was engaged to prepare a report for SA planning and development review identifying compliance, non-compliance and exemption in relation to attainment of states strategic objectives. A report has been submitted and the cost of the consultancy is \$8,235.

KPMG was engaged to report on requirements for undertaking a SA planning and development review. A report has been submitted and the cost of the consultancy is \$165,046.

National Strategic Services was engaged to assess cost of compliance for business to meet SA government policy directions. A report has been submitted and the cost of the consultancy is \$1,908.

Access Economics was engaged to perform an economic evaluation of the impact on skills and occupational demands arising from SA's major projects. A draft report has been provided. The cost of the consultancy is \$48,825.

Lizard Drinking was engaged to prepare a bioscience and advance technology industry business case. A report has been submitted and the cost of the consultancy is \$41,550.

VENTURE CAPITAL BOARD

In reply to Dr McFETRIDGE (Morphett) (26 June 2008).

The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations): I have been provided the following information:

The Venture Capital Board's scholarship program covers the cost of registration to attend the Venture Capital Institute in Atlanta, Georgia, USA plus an amount to defray the associated return economy airfare to get the scholarship winner from Adelaide to Atlanta and back. For 2008 the VCI registration cost is US\$3,000, which is at a discount from the standard registration cost, and is paid up-front on the scholarship winner's behalf.

The amount provided to defray the cost of a single return economy airfare from Adelaide to Atlanta for the 2008 scholarship is currently capped at \$3,500 and is provided as a reimbursement to the scholarship winners on provision of a trip report and evidence of their flight cost expenditure.

The VCI registration cost and airfare reimbursement cost are incurred by the office of the Venture Capital Board for each scholarship winner.

PARAGON PRIVATE EQUITY FUND 1

In reply to Dr McFETRIDGE (Morphett) (26 June 2008).

The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations): I have been provided the following information:

The state government has committed to invest up to \$7.7 million in the Paragon Private Equity Fund 1. Other investors have committed to invest up to \$26.2 million, making the state government's commitment 22.9 per cent of the total funds committed to invest into Paragon Private Equity Fund 1. Technically, the state government has not invested in Nukorc, Levett Engineering or Cowell Electric. Paragon Private Equity Fund 1 has made these investments.

Private equity fund managers do not often divulge the magnitude of their investments into the public domain, however in the case of Nukorc and Levett Engineering, Paragon Private Equity reported these two investments as \$3.5 million and \$1.5 million respectively. No information for the magnitude of the Cowell Electric investment was released into the public domain. The Nukorc investment occurred prior to the state government committing the \$7.7 million to the Paragon Private Equity Fund 1.

VENTURE CAPITAL BOARD

In reply to Dr McFETRIDGE (Morphett) (26 June 2008).

The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations): I have been provided the following information:

The Office of the Venture Capital Board (OVCB) does not pay any consulting fees directly to any of the eight full-time investment managers working with private sector funds based in Adelaide.

Standard industry practice has the investors in a private equity fund paying a management fee to the fund manager. This is usually a percentage of the total committed funds, generally between 1 per cent to 2.5 per cent, and is used to pay salaries and fund activities and services associated with undertaking investments and divestments. In line with this standard industry practice, the state government investment in the Paragon Private Equity Fund 1, does contribute to the management fee of the fund, on a pro-rata basis with all the other investors in the fund. The magnitude of Paragon's management fee is in line with standard industry practice.

No other management fees are paid through the OVCB to any other investment managers working with private sector funds based in Adelaide.

INVESTMENT REVALUATION

In reply to Dr McFETRIDGE (Morphett) (26 June 2008).

The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations): I have been advised that the revaluation was of the entire investment portfolio. The valuation for a specific investee company is not publicly available.

VENTURE CAPITAL BOARD

In reply to Dr McFETRIDGE (Morphett) (26 June 2008).

The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations): I have been provided the following information:

No external costs were incurred in facilitating and/or establishing the business angels network, SA Angels.

The work undertaken has included direct input from Office of the Venture Capital Board (OVCB) staff involved in facilitating and establishing the business angels network. OVCB staff have been involved in meeting with sophisticated investors and business angels, providing secretariat support and meeting co-ordination.

Facilitation has included sourcing opportunities for meetings with companies seeking angel investment. OVCB staff have worked with these companies to review information memoranda, management team capability, the investment opportunity and general equity readiness, and then introduced these companies to the business angel's network.

VENTURE CAPITAL BOARD

In reply to Dr McFETRIDGE (Morphett) (26 July 2008).

The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations): I have been provided the following information:

Most of the 36 educational networking activities are part of the Venture Capital Board's equity ready program, which is a program of workshops and activities providing awareness and understanding of what it takes to be ready to attract private equity investment. The program provides a pathway for companies to follow to give them the best chance of attracting private equity investment. There were some additional needs based activities specifically created as well.

The external cost of conducting the educational workshops in 2007-08 was \$43,300. This includes the direct costs of the private sector presenters, venue hire and costs of private equity reviews.

GST REVENUE

In reply to Mr GRIFFITHS (Goyder) (25 June 2008).

The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations): I am advised that information on GST revenue categorised by product is not available.

It is the case that for each 1 cent increase in the price of fuel 0.0909 cents of GST is remitted to the Australian Taxation Office, ie $1/11^{th}$.

How this translates into actual GST revenue received by the commonwealth from petrol depends on whether the purchaser is able to claim input tax credits (e.g. a registered business),

which nets against the GST collected on the sale, how sensitive petrol usage is to price increases, and the extent to which any increased spending on petrol is offset by lower spending on other goods and services subject to GST.

SHARED SERVICES

In reply to various members (25-27 June 2008).

The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations): I am advised that an across government collection of baseline data relating to agency corporate and business support services was undertaken in March 2007, using 2005-06 data.

Agencies provided a broad range of information relating to their corporate governance arrangements, including activity levels, volumes, costs and resources involved in the delivery of corporate and business support services during 2005-06.

The data has assisted in determining a shared services model suitable for implementation in the South Australian public sector.

Since the data was collected, agencies have continued to make changes to their corporate support functions, services and systems and hence, significant effort is expended by Shared Services SA during pre-transition and general discovery processes to gather more targeted and detailed information relating to in-scope services. As a result, some of the initial services where baseline data was collected have not been included, whilst the in-scope service designs have been refined and finalised.

To release 2005-06 agency baseline data now would misrepresent the current status of data collection could be misleading. Therefore, there is no plan to release it.

SHARED SERVICES

In reply to Mr GRIFFITHS (Goyder) (27 June 2008).

The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations): The former Minister for Finance the Hon. Michael Wright MP has provided the following information:

I confirm the Shared Services SA transition timetable dated as at 28 February 2008 available from the Shared Services SA website is the latest version.

This timetable provides the schedule for transition of Tranche 1 services to Shared Services SA in stages by grouping agencies into Group 1A, 1B, 2 and 3. The timetable also identifies that some agencies' Tranche 1 services will transition to Shared Services SA during Tranche 2, due to the inter-dependencies and nature of these services.

Tranche 2 services comprise HR reporting and administration, ICT infrastructure and network support and general accounting services. Initial planning has commenced on the service design of Tranche 2 services with their transition to Shared Services SA scheduled for 2009.

Tranche 3 services comprise fixed asset accounting, tax compliance, procurement consultancy and ICT user support, with preliminary planning for the transition of these services to Shared Services in 2009.

Transition timetables for Tranches 2 and 3 will be made available on the Shared Services SA website when they have been finalised.

SHARED SERVICES

In reply to Mr GRIFFITHS (Goyder) (27 June 2008).

The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations): The former Minister for Finance the Hon. Michael Wright MP has provided the following information:

A comprehensive across government data collection was undertaken in early 2007 where Agencies provided their 2005-06 data covering the volume activity, their cost and the full time equivalents involved in the delivery of all corporate and business services.

This identified some 6,000 FTEs engaged in corporate and business services in agencies, of which approximately 2,300 FTEs are performing functions that are considered to be potentially 'in scope' for shared services reform.

Prior to transition of services to Shared Services SA a detailed pre-transition discovery process is undertaken with agencies to validate and/or update the mainly quantitative data collected in early 2007.

The pre-transition discovery process undertaken for Groups 1A and 1B on the three priority services of payroll, accounts payable and accounts receivable revealed a reduction of in-scope FTEs when compared to the 2005-06 data. This is mainly due to the provision of clearer definition of in-scope activities compared to the information sought from agencies during the 2007 data collection.

FLEET SA

In reply to Mr GRIFFITHS (Goyder) (27 June 2008).

The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations): The former Minister for Finance the Hon. Michael Wright MP has provided the following information:

The average fleet management vehicle cost target of \$240 per vehicle, per annum, is influenced by the fleet size and costs incurred in managing the fleet (e.g. purchasing vehicles, fuel management, management of service and maintenance, and contract management). It is not related to the actual cost of the maintenance of the vehicle fleet. (Note that for 2007-08, 2,750 vehicles were purchased not 275,000 as per the question.)

The actual size of the fleet at 30 June 2008 was 8,481, comprising 8,209 long-term hire vehicles and 215 short term hire vehicles and 57 were awaiting allocation.

The average fleet management vehicle cost target was set a number of years ago. Fleet SA has continued to progress towards this target as shown in the table below.

It is expected that the \$240 target will be reached in 2008-09, based on the existing trend.

COURTS ADMINISTRATION AUTHORITY

In reply to Mrs REDMOND (Heysen) (26 June 2008).

The Hon. M.J. ATKINSON (Croydon—Attorney-General, Minister for Justice, Minister for Multicultural Affairs, Minister for Veterans' Affairs): I have received this advice:

It is my understanding that the Chief Judge of the District Court of South Australia has written to the Member for Heysen with additional information about the District Court civil backlog. The issues are the number of lodgements more than 12 months old represented 43 per cent, the disparity between that figure and the target of 10 per cent, and why personal injury matters have an effect on the backlog indicator.

Lodgements older than 12 months

The material prepared for the Estimates Committee was based on figures for the first complete quarter of 2008. As at 31 March, 2008, there were 3,128 civil matters pending, that being the total across all three civil divisions of the court, of which 1,332 (42.583 per cent) had been pending for more than 12 months. As explained in the budget papers, many of the District Court civil matter are personal injury matters. The nature of those matters is that they take longer than 12 months to resolve. That is because of the time it takes for the full extent of injuries to be assessed.

Similarly in the budget papers it is noted that performance against both the 12 month and 24 month standards for Supreme Court civil has show little movement. The greatest number of matters remain in the 'pre-trial' stage. A review of these matters by the masters confirmed that they are being actively managed towards finalisation.

It is my understanding that the full extent of psychological and physical injuries can often take several years to manifest themselves. Similarly long-term medical treatment can greatly

improve a plaintiff's physical health. Therefore these delays cannot be attributed to short comings within the CAA.

Target of 10 per cent

The Chief Judge noted in his letter to the Member for Heysen that the performance targets were fixed in the early 1990s for both the Supreme Court and the District Court by Chief Justice King and Chief Judge Brebner. As the Chief Judge understands, that was the first time such a target had been set in Australia and, although it was based on studies by Chief Judge Brebner of some US courts, there were no direct comparators available. It was an arbitrary figure and it was applied to both courts notwithstanding that their profiles were different. The targets have remained as they are for the reasons mentioned by the Chief Justice and the difference between the target and the estimated result of 43 per cent needs to be seen in that light.

Personal injury matters/backlog indicator

The Chief Judge explained in his letter that in each category of civil work except personal injuries, the number of files decreases as the files get older. However, in personal injury matters there is a significant disposal rate in the first 12 months but analysis by the registry shows that if they are not settled within the first 12 months, there is a good chance that they will take longer than two years to resolve.

The Chief Judge explained there are any number of reasons why some personal injury actions can take longer to mature, e.g. complex injuries that have not stabilised, causation issues, child plaintiffs or class actions. Whatever may be the reasons for personal injury files being open longer, because of the different trend in disposal they make up a greater proportion of files still pending more than 12 months after lodgement.

COURTS ADMINISTRATION AUTHORITY

In reply to Mrs REDMOND (Heysen) (26 June 2008).

The Hon. M.J. ATKINSON (Croydon—Attorney-General, Minister for Justice, Minister for Multicultural Affairs, Minister for Veterans' Affairs): I have received this advice:

Evaluations carried out by the Office of Crime Statistics and Research (OCSAR) indicates that both the Mental Impairment and the Drug Court programs reduce offending behaviour.

In 2004 the Office of Crime Statistics and Research published 'Magistrates Court Diversion Program: An Analysis of Post-Program Offending'. The full report can be accessed at the OCSAR website at www.ocsar.sa.gov.au. These points are drawn from that report:

- The total number of offending incidents committed before program entry was higher than
 the number detected post-program. Pre-program, the 157 participants who formed the
 study cohort were charged for 348 incidents. Post-program this decreased to 116. This
 difference was primarily owing to the large number of participants who did not offend at all
 in the 12 months after program completion.
- Two thirds (66.2 per cent) of program participants did not offend during their post-program year¹. One in three (30.5 per cent of the 157) were apprehended for three or more incidents pre-program compared with only 9 per cent of the group post-program.
- Just over three quarters (76.4 per cent) of the participants either became non-offenders or were charged with a smaller number of incidents post-program.
- 12.7 per cent remained the same—i.e. they were not apprehended for offending either preor post-program or were charged with the same number of incidents pre- or post-program.
- 10.8 per cent recorded more incidents post-program.

OCSAR published 'Offending Profiles & S.A. Drug Court Pilot Program Completers' in 2005. Once again it is available on the OCSAR website. It studied 43 participants who had completed the program by 31 March 2004 who had at least six months to offend after program completion. The report showed:

 Overall, there was a reduction in the number of 'completers' who were charged with a criminal event after program completion as well as a reduction in the actual number of criminal events charged against them.

- One quarter (10 or 23.3 per cent of the 43 'completers') were not charged with any offence in the 'free time' (ie, time not in custody) after program completion.
- Thirty four of 43 'completers' (79.1 per cent) were either not apprehended or were apprehended for fewer events post-program. In contrast, three were charged with the same number of events in both the pre- and post-program period, while six were charged with more events post-program.
- In terms of the seriousness of offending, of the four graduates who had been charged with at least one moderately serious offence pre-program, one had not been apprehended post-program, and two had been charged with minor offences only.
- Of the 39 serious offenders pre-program, nine had not been charged with any offence post-program, and 13 had been apprehended for minor offences only and three had been apprehended for a moderately serious offence.
- In total, then, nearly two-thirds of the 'completers' (65.1 per cent or 28 of the 43) had either not offended or were charged with less serious offences post-program.

OCSAR is responsible for research into and the monitoring of crime trends in the criminal justice system within the State. As well as the annual 'Crime and Justice in South Australia' publications, OCSAR researches on many topics each year.

Although OCSAR does not do a continuing assessment of the Drug Court and Mental Impairment Court, the intermittent studies show that the Courts are working as intended.

Thirty point six per cent of all fines raised during 2007-08 were collected without any follow up activities being necessary by the Courts Administration Authority (CAA) except for the initial notice advising of the amount of the fine.

The remaining 30.4 per cent of fines collected during 2007-08 required follow up activity by the CAA in order to collect. It should be noted that the success of the follow up needs to be measured over the years as some fine debtors have many fines and have entered into time payment arrangements that may take several years to complete. The CAA estimates that 30 per cent to 35 per cent of all fines raised will never be collected because some debtors are difficult to locate.

I refer to the following extract from the Hon. K.T. Griffin's second reading speech delivered on 9 July, 1998 for the Statutes Amendment (Fine Enforcement) Bill 1998, a bill which introduced the current fine recovery model.

It is natural for some individuals to avoid payment and their legal obligations deliberately. In some cases, people will acknowledge their legal obligation but ignore any action required to meet those obligations.

The Courts Administration Authority employ a variety of measures to extract fine payments from such unwilling debtors.

PUBLIC HOUSING REDEVELOPMENT FUNDING

In reply to Ms CHAPMAN (Bragg—Deputy Leader of the Opposition) (30 June 2008).

The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Northern Suburbs, Minister for Housing, Minister for Ageing, Minister for Disability): I am advised that the figure of \$168.977 million is the proposed expenditure for 2008-09. Total revenue from capital projects activities for 2007-08 was \$65.861 million which is broken down into \$19.853 million from newbuild and redevelopment and \$46.008 million from urban renewal projects, which includes land sales. Total revenue from other programs, including community housing, Aboriginal housing and other property sales (land and house) was \$98.601 million. Therefore, combined revenue from sales was \$164.462 million for 2007-08.

During 2007-08, there were 374 vacant house sales (including 30 Aboriginal housing sales).

EMERGENCY ACCOMMODATION

In reply to Ms CHAPMAN (Bragg—Deputy Leader of the Opposition) (30 June 2008).

The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Northern Suburbs, Minister for Housing, Minister for Ageing, Minister for Disability): In 2007-08, \$2.259 million was expended on emergency accommodation and \$13.745 million for the costs of carers. Backpackers' facilities have not been used for interim emergency accommodation.

In 2007-08, \$28.76 million was expended on contracts with non-government service providers for support to foster carers, and children's placements in small congregate care settings.

RURAL SECTOR NGOS

In reply to Mrs REDMOND (Heysen) (30 June 2008).

The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Northern Suburbs, Minister for Housing, Minister for Ageing, Minister for Disability): For the period August 2007 to June 2008, I am advised one placement occurred where a country client was placed outside of her local area. Specifically, one client residing in the northern country region was placed in a vacancy in the northern metropolitan region because the service that could provide the support required for her was not available in the country region.

I have been further advised that there were no placements of metropolitan clients into vacancies in country services.

DISABILITY SERVICES

In reply to Mrs REDMOND (Heysen) (30 June 2008).

The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Northern Suburbs, Minister for Housing, Minister for Ageing, Minister for Disability): Of the 4,856.5 full-time equivalents (FTEs) in the Department for Families and Communities for 2007-08, 1,829.3 FTEs are involved in the delivery of disability-related services.

Six of the 1,829.3 FTEs are for executive positions, comprising two in the Office for Disability and Client Services and four in Disability Services.

CHRIS DATA

In reply to Mrs REDMOND (Heysen) (30 June 2008).

The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Northern Suburbs, Minister for Housing, Minister for Ageing, Minister for Disability): The data held on CHRIS (Complete Human Resource Information System) does not distinguish between staff involved in administration duties and those involved in direct service. Employee details are held by classification.

ANTI-POVERTY SERVICES AND SPECIAL PROGRAMS FOR YOUTH

In reply to Ms CHAPMAN (Bragg—Deputy Leader of the Opposition) (30 June 2008).

The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Northern Suburbs, Minister for Housing, Minister for Ageing, Minister for Disability): The 2008-09 budget has provided \$15 million over four years to support families when they first come to the attention of Families SA, intervening early so that children can continue to safely live with their birth family. It is anticipated that some families who are currently recipients of Families SA anti-poverty services will be effectively supported through these early intervention services, and as a consequence reduce demand for emergency financial assistance.

In relation to funding for youth services, there is in fact an increase in the whole-of-government funding under the 'To Break the Cycle' initiative. A number of initiatives have been funded directly as a result of Monsignor Cappo's recommendations to address serious repeat offending. \$11.5 million has been committed over four years.

Community Protection Panel (CPP)—\$5.6 million

Intensive case management and concentrated support services will be provided to serious repeat offenders. A panel of experienced members of the community and government will oversee

this, and will recommend their return to custody if they do not fully take part in tailored programs. Additional youth justice case managers are being recruited to supervise these serious young offenders.

Youth Justice Teams—\$4 million

Young offenders who are not being supervised under the CPP will be closely supervised and receive tailored support programs from departments including the Department for Families and Communities, the Department of Health, the Department of Education and Children's Services and SA Police.

Tirkandi School Retention Program—\$1 million

This pilot program has been effective in keeping young at risk Aboriginal students at school and ongoing funding has been allocated. Evidence shows that poor educational achievement can be linked to offending behaviour.

The David Kennedy Model—\$829,000

Professor David Kennedy, from the John Jay College of Criminal Justice in New York, has been working with government and the Aboriginal community to devise a program tailored to address South Australian youth offending problems.

Kurruru Indigenous Youth Performing Arts—\$143,000 (additional funding)

Twenty adult artists and mentors are working with 100 young men and boys to provide a diversion from anti-social and criminal behaviour.

FAMILIES AND COMMUNITIES DEPARTMENT

In reply to Ms CHAPMAN (Bragg—Deputy Leader of the Opposition) (30 June 2008).

The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Northern Suburbs, Minister for Housing, Minister for Ageing, Minister for Disability): I am advised that the \$38 million referred to by you in your question relates to budget pressures in Disability SA and Families SA in 2006-07. However, the \$42 million referred to in budget paper 4, volume 3, page 10.10 relates to the budgeted increase in total operating expenditure for the Families and Communities Portfolio from the 2007-08 estimated result to the 2008-09 budget.

In response to your question in relation to 'savings being identified as reducing the government bail-out,' budget paper 4, volume 3, page 10.10 makes no reference to 'savings' or 'bail-out'. The budgeted increase in expenditure in the 2008-09 budget will be funded through additional commonwealth funding, expenditure of cash held by the department and additional funding from the government of \$35.4 million.

The budgeted increase to the portfolio expenditure is expected in the following areas:

- \$19.5 million additional reimbursement of land taxes, income taxes and stamp duties paid by the South Australian Housing Trust under the tax equivalent regime;
- \$15.5 million increase in expenditure relating to carryovers for community housing program (\$13.5 million) and crisis accommodation program (\$2 million);
- \$8.1 million expenditure relating to commonwealth funding for disability supported accommodation and a budgeted \$0.4 million increase in private rental assistance;
- \$10.1 million for additional Commonwealth State and Territory Disability Agreement expenditure;
- \$10 million additional expenditure relating to various children in care initiatives to address
 the growing demand for care placements as part of the reforms proposed in Keeping Them
 Safe—In Our Care; and
- \$2.4 million additional expenditure relating to implementing various initiatives in response to the recommendations outlined in the To Break the Cycle report.

Offset by:

- Once-off receipts in 2007-08, including:
- \$5 million for disability equipment
- \$4 million for Fover Accommodation at Port Adelaide

- \$2.8 million for Common Ground Limited at Port Augusta
- \$2 million for Novita Children's Services
- \$1.6 million for Tregenza Avenue Aged Care
- \$1.3 million for Support Accommodation Demonstration project
- \$0.5 million for Aboriginal and Torres Strait Islander programs
- \$3.4 million additional funding for Affordable Housing Innovation Fund
- \$3.2 million reduction in expenditure relating to the savings measures announced in the 2008-09 budget.

The balance is due to the impact of indexation, enterprise bargaining outcomes and deferred expenditure.



AUSTRALIA POST AND BILL EXPRESS

The Hon. G.E. GAGO (Minister for State/Local Government Relations, Minister for the Status of Women, Minister for Consumer Affairs, Minister for Government Enterprises, Minister Assisting the Minister for Transport, Infrastructure and Energy): I am advised:

The transaction fees for over the counter services are established by a head contract managed by the Department of Treasury and Finance. Agencies maintain separate purchase order arrangements with approved providers that can vary some conditions of service delivery but not the base transaction fee.

The fee paid to Australia Post for vehicle registration renewals in 2007-08 was \$1.30 per transaction (GST exclusive). The Department of Treasury and Finance has not yet advised of the new fee for 2008-09.

The fee paid to Bill Express in 2007-08 was \$0.99 per transaction (GST exclusive). This fee will remain fixed in 2008-09.

In addition, merchant card fees in relation to payments made on credit card through Australia Post and Bill Express are reimbursed at rates negotiated by the Department of Treasury and Finance under the same head contract.

The \$67,000 difference between 2007-08 estimated outcome and 2008-09 budget is entirely due to enterprise bargaining increases.

The \$40,000 difference between 2007-08 Budget and 2007-08 estimated outcome is mainly due to:

- \$20,000 enterprise bargaining increases;
- \$27,000 increase to provide administrative support to the Outback Areas Community
 Development Trust, Local Government Grants Commission and the Office for Southern
 Suburbs. This amount was fully recovered from these offices.

The above was slightly offset by a \$5,000 decrease due to a reduction in the payroll tax rate.

The 2008-09 budget for employee expenses (\$2,944,000) covers 32.3 FTE employees:

- 10 FTE employees for minister Rankine's office; and
- 22.3 FTE employees for the Office for State/Local Government Relations.
