#### GOVERNMENT HOUSE

In reply to **Mr HAMILTON-SMITH (Waite—Leader of the Opposition)** (25 June 2009).

**The Hon. M.D. RANN (Ramsay—Premier, Minister for Economic Development, Minister for Social Inclusion, Minister for the Arts, Minister for Sustainability and Climate Change):** I have been advised of the following:

As at 19 June 2009 there were 20.4 full time equivalent staff, including casuals, employed in Government House.

#### GOVERNMENT HOUSE

In reply to **Mr HAMILTON-SMITH (Waite—Leader of the Opposition)** (25 June 2009).

**The Hon. M.D. RANN (Ramsay—Premier, Minister for Economic Development, Minister for Social Inclusion, Minister for the Arts, Minister for Sustainability and Climate Change):** I have been advised of the following:

Additional specific services fall into two main categories, both resourced from within the State Governor's Establishment's operational budget (annual appropriation). These include the provision of security services, and the provision of gardening and landscaping services and grounds maintenance.

#### Security

The provision of a static security guard 24 hours a day, 7 days per week, and the constant monitoring of Government House's security systems are services provided by Police Security Services Branch (PSSB). PSSB also provide regular security patrols of the property, and a priority response service, in collaboration with South Australia Police, should it be required ie if Government House security systems detect an anomaly.

Cost: \$348,257.00 (payments made in the 2008-09 financial year to service contract).

#### Gardening and Landscaping

The company UrbanVirons has been contracted to provide gardening, landscaping and general grounds maintenance services to ensure the 5.6 hectares are presented in a way that complements the public role of the House and minimises water use, in accordance with the 2003 Landscape Management Plan. These activities include, but are not limited to:

- mowing and edging the lawns;
- undertaking planned planting activities;
- removal of leaf litter from driveways and lawns;
- specialised plant and tree maintenance;
- coordinating the irrigation regime of the grounds and the use of wetting agents to maximise water efficiency; and
- weed management and control.

Cost: \$162,046.21 (payments made in the 2008-09 financial year to service contract).

### SOCIAL INCLUSION INITIATIVES

In reply to **Mr HAMILTON-SMITH (Waite—Leader of the Opposition)** (25 June 2009).

**The Hon. M.D. RANN (Ramsay—Premier, Minister for Economic Development, Minister for Social Inclusion, Minister for the Arts, Minister for Sustainability and Climate Change):** I have been advised of the following:

In response to the first question put by the Hon Ian Evans MP, the increase in the Social Inclusion budget will be spent on the Social Inclusion Initiatives and is not funding for policy advice.

The variance in the budget between 2008-09 and 2009-10 is attributed to funding for two new Social Inclusion Initiatives through the Sharing Opportunities and Disability References, and decreased funding as a result of the scheduled end of a young offenders initiative (\$957,000 in 2008-09) and minor adjustments of \$56,000.

- \$4.529 million has been allocated from the 2009-10 State Budget for the delivery of two new innovative Social Inclusion Initiatives that will be established under the Sharing Opportunities Reference and Disability Reference. Delivery of these initiatives will be led by the relevant government agencies and the Social Inclusion Board, through the Social Inclusion Unit, will monitor implementation and evaluate outcomes.

In response to the second question put by Mr Evans, the Government has achieved improvements in school retention. South Australia's school retention rate has reached a 13 year high with 75.3 per cent of State government school students beginning high school in 2004 being retained to year 12 in 2008. In 1999 this retention rate was 67.2 per cent. Considerable progress has also been made towards implementing all 46 recommendations of the To Break the Cycle report to address the issue of serious repeat offending by young people.

### TOUR DOWN UNDER

### POPULATION GROWTH

In reply to **Mr GRIFFITHS (Goyder)** (25 June 2009).

**The Hon. M.D. RANN (Ramsay—Premier, Minister for Economic Development, Minister for Social Inclusion, Minister for the Arts, Minister for Sustainability and Climate Change):** I have been advised of the following:

While the Commonwealth announced cuts to the 2008-09 and 2009-10 migration intakes—to 108,100 national skilled places—these levels remain at historical highs. The Commonwealth, through its long-term immigration planning framework, has indicated a continuation of strong skilled migration to ensure that Australia maintains growth in its labour supply. This should see South Australia continue its own strong migration.

The South Australian Government will continue to promote the benefits of South Australia as a migration destination and actively encourage those with the skills our labour market needs to settle in this State. In doing so, we will continue to work with the Commonwealth to ensure state and national policy settings facilitate South Australia receiving its share of the national annual intake.

Supplementary Question:

Achievement of the 2 million target by 2027 is above current Australian Bureau of Statistics projections. However, South Australia has a recent history of exceeding ABS projections, including in 2003 when the ABS predicted our population would head into decline before 2030. That risk has now been averted due to our strong population growth.

Predicting with certainty whether our national population share will be at its current rate at 2027 is difficult. Many states will experience peaks and troughs in their performance in the next 20 years. What is clear is that South Australia's economy is well placed for considerable growth in coming years and decades, and should encourage continued strong population growth.

As at 30 April 2009 there were 35 actual persons in my ministerial office. The functions include a broad range of policy and media advice across government, and general office administrative services.

There were 11 actual persons in the Media Monitoring Unit. They provide a specialist media monitoring service for Government Ministers, other members of parliament and key staff.

#### PUBLIC SECTOR EMPLOYMENT

In reply to **Mr GRIFFITHS (Goyder)** (25 June 2009).

**The Hon. J.W. WEATHERILL (Cheltenham—Minister for Environment and Conservation, Minister for Early Childhood Development, Minister for Aboriginal Affairs and Reconciliation, Minister Assisting the Premier in Cabinet Business and Public Sector Management):** The Treasurer has provided the following information:

The figures quoted by the Member relate to the estimated FTEs at 30 June 2009 printed in Table 2.16 of the 2008-09 (81,841) and 2009-10 (83,326) Budget Papers, which are based on FTE caps for the general government sector and agency estimates for the Public Non-Financial Corporations and Public Financial Corporations sectors.

The FTE caps for the general government sector, which are administered by the Department of Treasury and Finance, are consistent with the level of salaries and wages budgets for each agency and are adjusted in line with changes to agency budgets.

As the caps are focused on monitoring and managing estimated agency employee expenses for the current and future years at the macro level, they do not estimate or record detailed FTE information such as employee classification or level. Consequently, the level of detail you seek is not available from the DTF FTE cap data.

Based on the DTF FTE cap data, the following information can be provided to explain the major variations in the following portfolios:

- Health +814 FTEs
- Justice +247 FTEs
- Environment and Conservation and the River Murray +97 FTEs
- Education -171 FTEs
- SA Water +72 FTEs
- South Australian Housing Trust +46 FTEs
- TransAdelaide +42 FTEs.

### COMMONWEALTH HEALTH PAYMENTS

In reply to **Mr HAMILTON-SMITH (Waite—Leader of the Opposition)** (25 June 2009).

**The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations):** I have been provided with the following information:

The reduction of \$64 million (6 per cent) in grants from the commonwealth for the health portfolio in 2009-10 primarily reflects the once-off receipt of \$104.9 million in 2008-09 for Hospital and Health Reform, which will be spent over the forward estimates; and the cessation at 30 June 2009 for essential vaccines and highly specialised drugs agreements under the former Australian Health Care Agreement (ACHA).

Ongoing Commonwealth funding for essential vaccines and highly specialised drugs were not included in the 2009-10 State Budget as the state did not have the agreements with the Commonwealth for this revenue and associated expenditure. New National Partnership agreements for essential vaccines and highly specialised drugs are being negotiated and it is estimated that the State will receive \$20.5 million for essential vaccines and \$49.6 million for highly specialised drugs in 2009-10.

### SUPERANNUATION SERVICES PROGRAM

**The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations):** I have been provided the following information:

The movement in the net cost of sub program 2.3 is relatively minor compared to the total cost of the sub program. The movements between published years are within 3 per cent of the total cost of sub program 2.3.

### SOUTHERN STATE SUPERANNUATION SCHEME

In reply to **Mr HAMILTON-SMITH (Waite—Leader of the Opposition)** (25 June 2009).

**The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations):** I have been provided with the following information:

The fees charged to a Triple S superannuation account include administration fees and investment management fees. Investment management fees are deducted by Funds SA prior to investment returns being declared, that is, member investment earnings are net of investment management fees. Administration fees are charged by Super SA and are currently \$52 per year.

Total fees (administration and investment management fees) on an account balance of \$40,000, which is the average Triple S account balance, are \$248 per annum. This compares very favourably with most other Superannuation Funds in Australia.

### SOUTHERN STATE SUPERANNUATION SCHEME

As at 30 June 2009, there are 13,314 public sector employees making salary sacrifice contributions. This includes members of the Triple S Scheme, and members of the Pension and Lump Sum Schemes who are making salary sacrifice contributions to a Triple S account. The total number of public sector employees salary sacrificing has increased by 19 per cent since 31 December 2007.

### ACCRUAL APPROPRIATION EXCESS FUNDS ACCOUNT

**The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations):** I have been provided with the following information:

The balance of the account was \$415 million as at 30 June 2008. Transfers in of \$60 million and transfers out of \$40 million occurred during 2008-09 resulting in a balance of \$435 million as at 30 June 2009.

In May 2007 the document titled Budgeting for Employee Entitlements etc document was released. This document includes a section covering for what purposes the account can be accessed. Agencies rely on this document and advice from the Department of Treasury and Finance to request correct amounts from the account. There have been no funding requests not approved.

**VOLUNTEER MINISTERIAL ADVISORY GROUP**

In reply to the **Hon. I.F. EVANS (Davenport)** (26 June 2009).

**The Hon. A. KOUTSANTONIS (West Torrens—Minister for Correctional Services, Minister for Gambling, Minister for Youth, Minister for Volunteers, Minister Assisting the Minister for Multicultural Affairs):** The Volunteer Ministerial Advisory Group is a robust group made up of representatives from volunteer organisations across South Australia. Like most advisory groups, the advice received from VMAG is frank and diverse. It is for this very reason that advisory groups exist.

Earlier this year, I met with the members of VMAG. I was pleased to note the enthusiasm the members have for the volunteering sector. This enthusiasm is matched by the Rann government's commitment to volunteering—as set out in the State's Strategic Plan.

I am very pleased with the way VMAG is operating and I look forward to having a long and productive relationship with VMAG in the future.

**DEFENCE SA**

In reply to **Mr GRIFFITHS (Goyder)** (26 June 2009).

**The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations):** I am advised, as highlighted by note (a) on page 2.3 of Budget Paper 4 Volume 1, the Full Time Equivalent (FTE) estimate reflects the established FTE cap, not the actual FTEs employed by the organisation. The actual number of FTEs as at 30 June 2009 is 30.3 FTEs. This represents an increase of 4.9 FTE from the 30 June 2008 actual of 25.9.

The reasons for the increase are:

- The conversion of two contract positions within the Business Development group to term employment positions (Director Maritime and Director Land); and
- The establishment of the Common User Facility operations team with three positions appointed (Manager of Operations, Maintenance Manager and Systems and Safety Manager).

These were offset by minor variations in work hours for two other Defence SA employees.

**DEFENCE SA**

In reply to **Mr GRIFFITHS (Goyder)** (26 June 2009).

**The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations):** I am advised subdivision and servicing of land within the Techport Australia Supplier Precinct has yielded 13 allotments marketed as Stage One. This stage comprises approximately 108,143 square metres of available land of which 51,929 square metres (approximately half) has been sold.

The State Budget for 2009-10 commits \$7.31 million for site geotechnical preparation works for stages three and four in Techport Australia and the adjacent Osborne North Industrial Precinct, to provide quality serviced industrial allotments for defence and other industries.

The proposed precinct development involves subdivision and servicing of approximately 364,780 square metres of land to create 31 serviced allotments ranging from 4,814 square metres to 18,710 square metres.

The precinct will be developed over the next two years, with sales to commence from 2011. The development is proposed to occur in at least two stages, subject to market demand.

**DEFENCE SA**

In reply to **Mr HAMILTON-SMITH (Waite—Leader of the Opposition)** (26 June 2009).

**The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations):** I am advised that should the Common User Facility not be available as required by the Commonwealth, in accordance with the Design Development Deed, the Minister for Economic Development is required to indemnify the Commonwealth for actual losses incurred due to the delay. At this point in time, the state cannot estimate what losses may be incurred by the Commonwealth due to project delays. As previously

stated, Defence SA is confident that the facility will be available as required and the Commonwealth will not experience any delays.

### **SOUTH AUSTRALIAN EVENTS PROMOTION**

In reply to **Mr GRIFFITHS (Goyder)** (26 June 2009).

**The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations):** Investment attraction luncheons were held in Sydney and Melbourne during 2008-09, attended by senior executives from significant companies based in these capitals.

The purpose of the luncheons was to promote investment opportunities in South Australia to chief executives and senior personnel from national and international companies in Sydney and Melbourne. Guests received presentations by:

- The Premier;
- Dr Ian Gould, Chairman of the South Australian Minerals and Petroleum Expert Group (SAMPEG) and member of the Economic Development Board on the resources sector; and
- Mr Andrew Fletcher, Chief Executive of Defence SA on opportunities and developments in the defence sector in South Australia.

I am advised that the cost of the Sydney Investment Attraction Luncheon held on Friday 28 November 2008 was \$27,303.66. The cost of the Melbourne Investment Attraction Luncheon held on Thursday 12 March 2009 was \$19,765.05.

### **OVERSEAS REPRESENTATIVE OFFICE PROGRAM**

In reply to **Mr GRIFFITHS (Goyder)** (26 June 2009).

**The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations):** The Department of Trade and Economic Development operates offices in strategic overseas markets which provide in-market support to South Australian companies.

I am advised that the estimated cost of the overseas offices in 2008-09 was \$3.446 million.

Offices are located in China (Shanghai, Jinan and Hong Kong), India (Chennai), Singapore (including Malaysia), Middle East (Dubai), Chile (Santiago) and Vietnam (Ho Chi Minh City).

### **BUSINESS INVESTMENT**

In reply to **Mr GRIFFITHS (Goyder)** (26 June 2009).

**The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations):**

Business investment in South Australia was \$9.3 billion in 2007-08.

Business investment at the national level was \$182.4 billion in 2007-08.

Business investment at the national level recorded stronger growth than in South Australia over the period due to relatively stronger growth in new machinery and equipment and non-dwelling construction (primarily new engineering). To some extent this is due to the larger mining industries in Queensland and Western Australia. South Australia's mining industry is still in a relatively embryonic state with large amounts of mineral exploration but not yet as much mine development and production.

In 2007-08 South Australia's business investment was predominantly made up of new machinery and equipment (53 per cent), new building construction (19 per cent), and new engineering construction (18 per cent).

In 2007-08 national business investment was predominantly made up of new machinery and equipment (49 per cent), new building construction (23 per cent), and new engineering construction (21 per cent)

Business investment reached \$10.3 billion in the year to the March quarter 2009—a record high and an increase of 9.5 per cent. Business investment data for the full financial year of 2008-09 is not yet available.

### RED TAPE REDUCTION

In reply to **Mr GRIFFITHS (Goyder)** (26 June 2009).

**The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations):** In August 2008, the government released a report detailing over 180 red tape reduction initiatives that will contribute net savings to business of \$170 million per year. A copy of this report has been provided to the member. Included in the report as an attachment is a copy of the final Deloitte audit.

Examples of just a few of the savings initiatives from the report that were signed off by Deloitte include:

- Reduction in the time taken to process land services applications
- Amendment of the trade measurement regulations for wine labelling
- Review of OHS&W regulations to ensure national and international best practice
- Reduction in the number of businesses required to undertake environmental monitoring under EPA licensing
- Review of state taxation legislation to remove redundant provisions and unnecessary regulatory burdens
- Development of an online system for Business Names Registration and Person Approval applications.

The report also includes savings from a number of planning related initiatives. However, the estimated \$50 million in red tape savings to commercial developers as a direct result of the South Australian Government's Planning and Development Review were not included. This was because the Review outcomes were not implemented until after 30 June 2008. These savings, which are being delivered now, will contribute to the Government's second red tape reduction target of \$150 million announced by the Premier in April this year.

**The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations):** I have been provided with the following information:

The full time equivalents for 30 June 2008 quoted in budget paper 4 Volume 1 page 2.3 was 181.8. This number represents the number of filled positions out of a total establishment of 206 full time equivalents. 24.2 full time equivalents were unfilled. The movement between 206 full time equivalents and the 2008-9 Estimated Result of 214.8 was 8.8 full time equivalents.

The net increase of 8.8 FTE is due to:

- 4 additional FTE for graduate positions
- 4 additional FTE for the Olympic Dam Task Force
- 1.8 additional FTE transferred to DTED from other agencies previously provided to DTED under shared services arrangements

- 2.5 additional FTE transferred into DTED with the transfer of the Creative Industries Team from DPC
- -1 FTE for the Regionalisation of SASP (one year program only)
- -1 FTE Office of the Venture Capital board positions (Chief Executive) being no longer required with the transfer to DTED
- -1 FTE transferred out to Cabinet office to support its establishment
- -0.5 FTE change in part time hours for some employees

The mid year budget review for 2008-9 required DTED to reduce by 10 full time equivalents for the 2009-10 year. This has been achieved simultaneously to the restructure. The restructure has resulted in 39 positions being abolished with 29 new positions being created which are aligned to the priority areas of the Department in accordance with the Strategic Directions 2009-14.

#### MIGRATION

In reply to **Ms CHAPMAN (Bragg—Deputy Leader of the Opposition)** (26 June 2009).

**The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations):** I have been provided with the following information:

The number of interstate arrivals to South Australia in the financial year for which statistics are currently collected (2008-09) is 10,849 people to December 2008 (ABS Catalogue No. 3101.0, Australian Demographic Statistics). Although an incomplete financial year, the number of arrivals so far compares with the figure for the 2007-08 year of 22,350 people.

#### MIGRATION AND BUSINESS INVESTMENT CAMPAIGN

In reply to **Ms CHAPMAN (Bragg)** (26 June 2009).

**The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Industry and Trade, Minister for Federal/State Relations):** I have been provided with the following information:

The total spend for the 2008-09 Interstate Migration Campaign was \$705,031.07.

Total advertising spend for the Interstate Business Investment Campaign for 2008-09 was \$756,755.32.

#### PENSIONER CONCESSIONS

In reply to **Mrs REDMOND (Heysen)** (29 June 2009).

**The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Northern Suburbs, Minister for Housing, Minister for Ageing, Minister for Disability):** A recent examination of the cost of four key household expenses between 2002 and 2008 showed that costs for energy, water, sewerage and council rates, calculated by 'average household' measures and 'average rates', increased by 31 per cent between 2002 and 2008. The maximum total package of State Government concessions available to aged pensioners in an 'average household' increased by 24 per cent in the same period.

In addition to the 24 per cent increase in State Government concessions, two new Commonwealth Government payments, the Utility Allowance and the Seniors Concession Allowance were introduced to support pensioners and Commonwealth Seniors Health Card holders. This is a further payment of \$507 per annum.

The combined effect of these increases shows that the total package of State and Commonwealth Governments' support available to older South Australians for common household expenses has increased by 148 per cent since 2002, outstripping the 31 per cent increase in household costs for the same period.

#### HOMESTART FINANCE

In reply to **Ms CHAPMAN (Bragg—Deputy Leader of the Opposition)** (29 June 2009).

**The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Northern Suburbs, Minister for Housing, Minister for Ageing, Minister for Disability):** HomeStart Finance's forecast dividend and tax-equivalent payments are derived from a financial



model which takes into account the economic and market environment. A number of factors influence future profits, including forecast interest rates and lending volumes.

The decline in expected dividend and tax-equivalent payments in 2012-13, when compared with 2011-12, partially reflects the interest rate forecasts (sourced from the private sector) used at the time and other market influences which are anticipated to have minimal impact on the profitability of HomeStart Finance.

### PUBLIC HOUSING

In reply to **Ms CHAPMAN (Bragg—Deputy Leader of the Opposition)** (29 June 2009).

**The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Northern Suburbs, Minister for Housing, Minister for Ageing, Minister for Disability):** In relation to past Commonwealth/State housing agreements the State Government owes the Commonwealth Government \$619.60 million at 30 June 2009.

### NATIONAL DISABILITY AGREEMENT

In reply to **Ms CHAPMAN (Bragg—Deputy Leader of the Opposition)** (29 June 2009).

**The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Northern Suburbs, Minister for Housing, Minister for Ageing, Minister for Disability):** The growth factor for the National Disability Agreement is a rolling five year average of nominal Gross Domestic Product (GDP) year-on-year growth, to be applied each year as of 1 July 2010. At the time of signing the Agreement this was estimated to be approximately 6 per cent per annum.

I am advised, since this time, the figure has been revised downward. The Federal Budget papers of May 2009 estimate that the growth factor to be applied for 2010-11 will be 5 per cent, owing to lower than anticipated growth in nominal GDP.

### DISABILITY SERVICES, WAITING LISTS

In reply to **Ms CHAPMAN (Bragg—Deputy Leader of the Opposition)** (29 June 2009).

**The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Northern Suburbs, Minister for Housing, Minister for Ageing, Minister for Disability):** As at 30 June 2008 there were 315 adults waiting for equipment. The average waiting time for the provision of equipment once the clinical assessment and prescription was completed was 175 days. As at 30 June 2009 there were 8 adults waiting for equipment. The average waiting time for the provision of equipment once the clinical assessment and prescription was completed has reduced by 149 days to 26 days.

As at 30 June 2008, there were 390 children waiting for equipment from Novita Children's Services with a waiting time average of approximately 252 days. As at 30 June 2009, there were 393 children waiting for equipment from Novita Children's Services, with an average client wait time of 252 days.

### AUTISM WAITING LISTS

In reply to **Ms CHAPMAN (Bragg—Deputy Leader of the Opposition)** (29 June 2009).

**The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Northern Suburbs, Minister for Housing, Minister for Ageing, Minister for Disability):** Children who require diagnostic assessments for Autism Spectrum Disorders can access these from various providers: Autism SA; private practitioners such as psychologists, speech therapists, paediatricians and psychiatrists; and via public health services such as the Child Development Units at the Women's and Children's Hospital, the Lyell McEwin Hospital and the Child Assessment Team at Flinders Medical Centre.

There is not a single waiting list for diagnostic assessments for Autism Spectrum Disorders for children and waiting times vary between services and practitioners.

### DISABILITY SERVICES, COMMUNITY ACCOMMODATION

In reply to **Ms CHAPMAN (Bragg—Deputy Leader of the Opposition)** (29 June 2009).

**The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Northern Suburbs, Minister for Housing, Minister for Ageing, Minister for Disability):** The 2008-09 highlight 'moved approximately 80 people to supported community accommodation or more appropriate accommodation' relates specifically to de-institutionalisation programs managed by Disability Services. It does not represent the total number of people assisted into supported accommodation or more appropriate accommodation.

All eighty people were already in some form of supported accommodation. Sixty-nine had been living in another form of supported accommodation operated by Disability Services and eleven had been either residing in, or were at risk of entering residential aged care and were therefore listed as Category 1.

The information required under Section 9 of the Julia Farr Services (Trusts) Act 2007 relating to the Department for Families and Communities Annual Report 2007-08 was omitted due to an administrative oversight by the Department and was not picked up by the Auditor-General. This will be corrected in accordance with the Department of the Premier and Cabinet Circular PC013, Annual Reporting Requirements.

As at 30 March 2008, 128 people with disabilities were resident at the Fullarton Campus. With respect to the people resident at a place other than the Fullarton Campus, people have returned to a range of supported community accommodation.

### DISABLED AND ELDERLY PERSONS, SUPPORT PROGRAMS

**The Hon. J.M. #### GRANT EXPENDITURE

In reply to **Mrs REDMOND (Heysen)** (29 June 2009).

**The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Northern Suburbs, Minister for Housing, Minister for Ageing, Minister for Disability):** I have been advised that the Northern Connections Office under the Department for Planning and Local Government had no expenditure on grants during the 2008-09 financial year.

#### INDUSTRIAL ACTION

In reply to **Dr McFETRIDGE (Morphett)** (30 June 2009).

**The Hon. P. CAICA (Colton—Minister for Agriculture, Food and Fisheries, Minister for Industrial Relations, Minister for Forests, Minister for Regional Development):** I am advised:

1. On 30 June 2009, I provided the committee with information on Industrial Disputation for the South Australian Public Sector for the financial year from 1 July 2008 to 30 May 2009. At that time I reported the latest available information in number of hours lost per thousand employees, which was 644 hours. This translates into 85.8 days lost per thousand employees.

I am now able to provide information for the full financial year to 30 June 2009 stated in terms of days lost. The number of days lost through Industrial Disputation in the South Australian Public Sector for the period 1 July 2008 to 30 June 2009 was 86.06 days (645 hours) per thousand employees.

This compares to a total of approximately 103 days per thousand employees lost to Public Sector Industrial Disputation for the period 1 July 2007 to 30 June 2008. By comparison, the national total was 165 days lost per thousand employees for the same period, as reported by the Australian Bureau of Statistics (ABS).

In reporting the national total, the ABS catalogue data does not distinguish between private and public sector disputation and comparative data with other state public sector performance is not readily available.

ABS Data for the June 2009 quarter is currently unavailable. However, the ABS has reported for the three quarters to March 2009 and the total number of days lost nationally to industrial disputation was 78.9 days per thousand employees.

#### FISHERIES COMPLIANCE AND ENFORCEMENT COSTS

In reply to **Mr PEDERICK (Hammond)** (30 June 2009).

**The Hon. P. CAICA (Colton—Minister for Agriculture, Food and Fisheries, Minister for Industrial Relations, Minister for Forests, Minister for Regional Development):** I am advised:

1. The fisheries compliance service costs recovered through commercial fisheries licence fees was \$4.29 million of the total \$11.3 million collected. Included in these costs were \$3.67 million for fisheries officers to conduct enforcement and general patrol work across South Australian waters; \$142,314 for quota monitoring services across a number of different quota management fisheries, such as abalone, rock lobster, sardines and blue crab, and \$351,897 for operation of the large fisheries patrol vessel 'Southern Ranger'.

## OUTBACK COMMUNITIES (ADMINISTRATION AND MANAGEMENT) BILL

In reply to **Mr GRIFFITHS (Goyder)** (30 June 2009).

**The Hon. P. CAICA (Colton—Minister for Agriculture, Food and Fisheries, Minister for Industrial Relations, Minister for Forests, Minister for Regional Development):** I am advised:

1. There was no Regional Impact Assessment Statement (RIAS) undertaken. As per the RIAS policy, a statement is only needed when there is a significant change in services to regions. I am further advised that considerable consultation was undertaken with the affected communities on options in preparing this Bill. In addition, the Bill itself requires considerable consultation prior to the implementation of some key matters.

### REGIONAL IMPACT STATEMENTS

In reply to **Mr GRIFFITHS (Goyder)** (30 June 2009).

**The Hon. P. CAICA (Colton—Minister for Agriculture, Food and Fisheries, Minister for Industrial Relations, Minister for Forests, Minister for Regional Development):** I am advised:

Statistics have been compiled since November 2008 with the introduction of Electronic Cabinet Online (ECO). From November 2008 to August 2009, a total of 220 Regional Impact Statements have gone to Cabinet. Topics of the Cabinet Submissions are covered by Cabinet Confidentiality.

### OUTBACK CATTLE DRIVE

In reply to **Mr PISONI (Unley)** (30 June 2009).

**The Hon. J.D. LOMAX-SMITH (Adelaide—Minister for Education, Minister for Mental Health and Substance Abuse, Minister for Tourism, Minister for the City of Adelaide):** The South Australian Tourism Commission has advised the following:

The Cattle Drive Familiarisation program was held in May 2009 and cost \$170,000, of which \$90,000 was funded by the Federal Government.

It is expected that the 2010 Great Outback Cattle Drive to be held in August will generate more than \$9 million in media coverage.

### EMPLOYEE BENEFITS AND COSTS

In reply to **Mr GRIFFITHS (Goyder)** (1 July 2009).

**The Hon. P. HOLLOWAY (Minister for Mineral Resources Development, Minister for Urban Development and Planning, Minister for Small Business):** The cost of advertising vacancies within the Department of Planning and Local Government is included in the supplies and services budget line not the employee benefits and costs budget line. The amount that was spent on advertising vacancies within the whole department for the 2008-09 financial year was \$38,628.44.

### UNFUNDED DRILLING PROPOSALS

In reply to **Mr PEDERICK (Hammond)** (1 July 2009).

**The Hon. P. HOLLOWAY (Minister for Mineral Resources Development, Minister for Urban Development and Planning, Minister for Small Business):** As part of the PACE Initiative, the Department of Primary Industries and Resources (PIRSA) maintains regular contact with all companies that conduct exploration drilling through Theme 2 Drilling Collaborations between PIRSA and Industry.

PIRSA does not, however monitor or track the progress of unsuccessful proposals.

There have been five rounds of drilling collaborations between 2004 and 2009 with a total of 335 drilling proposals submitted. 168 proposals were successful in receiving funding while 167 were unsuccessful.

The 167 projects that did not receive funding are comprised not only of proposals that did not meet the strict technical and scientific scrutiny but proposals that may have been resubmitted over successive rounds or initially unsuccessful but later received funding.

To determine the information requested by Mr Pederick direct contact with each company would be required relying on the availability of company representatives, timely responses and a willingness to provide potentially confidential information that companies are under no obligation to provide.

I have informed PIRSA and its Minerals and Energy Resources Division of the question and PIRSA will endeavour to collect this information in the future.
