EMERGENCY SURGERY DEPARTMENTS

In reply to **Dr McFETRIDGE (Morphett)** (30 June 2011).

The Hon. J.D. HILL (Kaurna—Minister for Health, Minister for Mental Health and Substance Abuse, Minister for the Southern Suburbs, Minister Assisting the Premier in the Arts): I am advised:

The waiting time is defined as the difference between the date/time of the first operating theatre and the admission date/time for patients admitted via an Emergency Department.

The average waiting time for emergency surgery has decreased by 8.4 hours over the past two years. In May 2009 the average waiting time was 49.9 hours, and decreased to 44.8 hours in May 2010, and decreased further to 41.5 hours in May 2011.

FLINDERS MEDICAL CENTRE

In reply to **Dr McFETRIDGE (Morphett)** (30 June 2011).

The Hon. J.D. HILL (Kaurna—Minister for Health, Minister for Mental Health and Substance Abuse, Minister for the Southern Suburbs, Minister Assisting the Premier in the Arts): I am advised:

1. There is a known issue with CapPlan, where occasionally patients discharges are missed during the data exchange. As such, these patients show in CapPlan as accruing time although they have been discharged. This issue is currently being resolved with the vendor. As a result, internal data sources at the Flinders Medical Centre are utilised for monitoring average length of stay (ALOS) calculations while the issue is being resolved.

2. 1 January 2011—30 June 2011, the ALOS for patients leaving the Flinders Medical Centre Emergency Department is currently 3.81 hours. The ALOS for patients who left the Emergency Department on 23 June 2011 was 5.17 hours (median 4.6 hours), and on 30 June 2011 was 5.67 (median 4.59).

ADELAIDE HEALTH SERVICE

HENDERCARE

In reply to **Ms CHAPMAN (Bragg)** (30 June 2011).

The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Housing, Minister for Ageing, Minister for Disability): It is recorded on the SA Tenders and Contracts website that the estimated cost for HenderCare to provide emergency care services at the Tregenza facility from 1 July 2010 to 31 January 2011 would be \$1.88 million.

For the period 1 July 2010 to 31 January 2011, the actual payment to HenderCare was \$1.69 million, \$0.19 million less than the estimated cost to support the establishment of emergency care services at the Tregenza facility.

HenderCare has continued to provide support at the facility pending recruitment of sufficient departmental staff to independently run the service. It is anticipated that departmental staff will fully staff the Tregenza facility over the next 12 months.

FAMILIES AND COMMUNITIES ORGANISATIONAL CAPABILITY

In reply to **Ms CHAPMAN (Bragg)** (30 June 2011).

The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Housing, Minister for Ageing, Minister for Disability): The budgeted increase in 'other expenses' for Program 6 (Organisational Capability) is primarily a reflection of an anticipated increase in provisions for workers compensation liabilities. This increase was due to an allowance for an expected increase in the workers compensation liability arising from the annual actuarial review.

The review takes into account factors such as the long-term government bond rate, cost escalation in salary and medical expenses and recent claim experience. This increased budget provision relates to the operations of the entire department and is held centrally within Program 6. This is the main factor driving the observed increase in 'other expenses' for Program 6.

APY LANDS, FAMILIES SA

In reply to **Ms CHAPMAN (Bragg)** (8 October 2010).

The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Housing, Minister for Ageing, Minister for Disability): Families SA provides outreach services on the APY Lands from its Coober Pedy Office. This includes the provision of child protection, youth justice and family support services.

In line with the recommendations of the Children on the APY Lands Commission of Inquiry Report:

- Families SA have six Lands Based Worker positions assigned to Amata, Iwantja (Indulkana) and Kaltji (Fregon), Pukatja (Ernabella), Pipalyatjara and Mimili who conduct work with a heightened focus on early intervention and prevention strategies.
- Two Families SA Child Protection Workers have also been assigned specifically to the APY Lands to undertake specific investigation and assessments of child protection matters.
- Funding for these eight positions for 2010-11 is approximately \$1.5 million.

There are also a number of additional initiatives provided by the State Government and Commonwealth Government to the APY Lands. These include:

- Ernabella Child and Family Centre: A central point for the delivery and coordination of early childhood and parenting programs in Ernabella. DFC provided funding of approximately \$75,000 in 2009-10, with approximately \$150,000 committed in 2010-11.
- Relationships Australia Parenting Program: Delivers a parenting support program in Ernabella coordinated through the Ernabella Child and Family Centre. The program commenced in June 2010 with DFC providing funding of approximately \$150,000.
- DFC Family Centres: In Mimili, Fregon, Ernabella (Ernabella Child and Family Centre), Amata and Pipalyatjara, the centres provide an informal venue for parents and children to participate in a range of parenting support programs and a meals program for young children who have been identified as requiring additional nutrition. Family Centres cost approximately \$800,000 per year to operate.
- Cross Border/APY Lands Aboriginal Family Violence Service: Delivered by the Ngaanyatjarra Pitjantjatjara Yankunytjatjara (NPY) Women's Council, responds to incoming referrals, undertakes assessments, case work, case management, outreach support and respite support for women and children living on the APY Lands that are experiencing domestic/family violence. In 2010-11 the NPY Women's Council will receive \$310,200 in funding, comprising \$136,488 from the South Australian Government and \$173,712 from the Commonwealth Government.

- Home Living Skills Program: Delivered by UnitingCare Wesley on behalf of Housing SA to communities across the APY Lands to improve the ability of tenants to successfully maintain their tenancy and increase the household's knowledge about the nine Healthy Living Standards. The program commenced during 2010-11 in the communities of Amata, Mimili and Fregon, and will be moving to Pipalyatjara later in the financial year. The program is funded through the Commonwealth Government with \$440,000 from the National Partnership Agreement on Remote Indigenous Housing in 2010-11.

The Hon. A. KOUTSANTONIS (West Torrens—Minister for Mineral Resources Development, Minister for Industry and Trade, Minister for Small Business, Minister for Correctional Services): I am advised that the document 'Case for Adelaide—Tiger Airways' originated from the Department of Trade and Economic Development and was presented to Mr Tony Davis, Chief Executive Officer, Tiger Airways in Sydney on 1 March 2007 by Mr Raymond Garrand, the then Chief Executive and others.

The document was prepared as part of the South Australian Government's business case for the Response to Request for Proposal for Tiger Airways' Australia Initial Aircraft Base(s).

The business case was subject to legal advice and approval from the Board of Directors of Tiger Airways, the Board of Directors of Adelaide Airport Limited and Cabinet.

The South Australian Government's business case to secure Tiger Airways' Australia Initial Aircraft Base(s) was not successful. Tiger announced its decision to establish the Initial Aircraft Base in Melbourne in May 2007.

CHOWILLA CREEK

In reply to **Mr WHETSTONE (Chaffey)** (5 July 2011).

The Hon. P. CAICA (Colton—Minister for Environment and Conservation, Minister for the River Murray, Minister for Water): I am advised:

Due to increased water levels, work in Chowilla Creek became unsafe for contractors from the end of September 2010. Work continued on other areas of the site until the end of November when the whole site was closed and all plant and equipment removed. Now that winter rains have started it is unlikely that work will recommence before October 2011.

Although there is a State contribution to Murray-Darling Basin Authority (MDBA) operations, this is a federally funded project and the cost of flooding construction sites along the entire river system is being paid from an MDBA emergency fund. As a result there will be no impact on the State budget.

WATER RECYCLING

In reply to **Mr WILLIAMS (MacKillop—Deputy Leader of the Opposition)** (5 July 2011).

The Hon. P. CAICA (Colton—Minister for Environment and Conservation, Minister for the River Murray, Minister for Water): I am advised:

1. Within the last financial year, 506ml of recycled water was used from the Glenelg to Adelaide Parklands Recycled Water pipeline.
2. To date, 26 organisations have committed to recycled water usage, totalling 1,539ml/annum. These customers include councils, schools and businesses.

It should be noted that some committed customers are not presently taking water are making the necessary alterations and modifications to their on-property systems. It is expected that these customers will commence using recycled water this summer.
