### QUESTIONS.

# GIFT WHEAT TO PAKISTAN.

The Hon. F. J. CONDON—I ask leave to make a brief statement with a view to asking a question.

Leave granted.

The Hon. F. J. CONDON-On July 15 the Minister for External Affairs, Mr. Casey, stated that the Australian Government was donating to Pakistan 3,000 tons of wheat worth approximately £100,000. This was the second gift of wheat, a much larger amount having been given previously. As the Premier leaves for Canberra tomorrow will the Chief Secretary ask him to discuss with the Acting Prime Minister the desirability of making any further gifts in the shape of flour instead of wheat? The milling industry throughout Australia has had a very bad time in the last two years and it would mean a great deal to the industry if the wheat could be gristed before shipment.

The Hon. Sir LYELL McEWIN—I will bring the honourable member's remarks under the notice of the Premier. It depends, of course, on what represents the greatest economic advantage to both parties.

## MURRAY AREA ROADS.

The Hon. J. L. COWAN—Will the Minister of Roads inform the House whether it is the intention of the Government to make special grants to councils for the maintenance of district and other roads now carrying abnormal traffic owing to the River Murray flooding main roads and ferry approaches?

The Hon. N. L. JUDE—The Government is fully aware of the additional traffic carried by roads adjacent to the River Murray, and already many thousands of pounds have been allocated to district councils for their maintenance. Unfortunately, it will be necessary for grants to continue to be made because of the great disaster along the river.

# SUBSIDIES FOR DENOMINATIONAL SCHOOLS.

The Hon. S. C. BEVAN—In view of the Federal Government's recognition of the need to subsidize private denominational schools in Canberra, can the Chief Secretary state whether it is the intention of this Government to subsidize similar schools in South Australia?

The Hon. Sir LYELL McEWIN—Although I have noticed some discussion in the newspapers, I do not know whether that has actually been done. There seems to have been agreement in some quarters and not in others. This involves a matter of policy, therefore I will see that it is considered.

## MARGARINE QUOTAS.

The Hon. F. J. CONDON—For the third year in succession margarine factories have been forced to close down because they have reached their quotas. Can the Chief Secretary state whether the Government intends to introduce a Bill to amend the Margarine Act so as to permit people to purchase this much needed article?

The Hon. Sir LYELL McEWIN—A meeting of the Agricultural Council is at present in progress, and when I read the result of its deliberations I may have some information regarding this matter.
