Answers to Questions

TRANSPORT DEPARTMENT CAR PARK

In reply to the Hon. M.C. PARNELL (17 March 2021).

The Hon. R.I. LUCAS (Treasurer): The Minister for Infrastructure and Transport has advised:

The land referred to is known as Lot 13 Holton Court, Joslin and is a parcel of land vested in the Commissioner of Highways.

Prior to the site being developed as a car park for the former Highways Department in the late 1960s, it was used as a refuse deposit by the local council.

The Department for Infrastructure and Transport (DIT) commissioned a site contamination audit in 2015 which concluded that site contamination existed at the site in concentrations not suitable for recreational/open space land use

The purpose of the report was to seek independent advice to assist with understanding the potential cost and works associated to render the site suitable for future potential development from residential through to commercial or industrial use (including recreational consideration).

On 1 February 2019 Cohda Wireless entered into a licence agreement with DIT over the site for the purpose of testing autonomous vehicles. This licence is currently in holdover.

The site is currently within the DIT sales program with an aim to bring the land to market and return its value to the Highways Fund subject to any state agency or council interest in retaining the land.

HOVE LEVEL CROSSING

On 22 June 2021 the state government announced that following extensive stakeholder consultation, the Brighton Road, Hove level crossing project will not be proceeding.

SOLAR ENERGY

In reply to the Hon. J.A. DARLEY (26 May 2021).

The Hon. R.I. LUCAS (Treasurer): The Minister for Energy and Mining has advised:

The South Australian government sees roles for both grid-scale batteries and much smaller batteries attached to peoples' homes or businesses. Both will increase the amount of storage available and will help to address grid management issues. In rolling out the South Australian government's \$118 million Home Battery Scheme (HBS), equity and grid management were front of mind. The HBS provides a higher subsidy level for concession card holders and only allows smart batteries that are capable of operating in virtual power plants to be installed, to maximise their potential value in reducing bills whilst supporting the market and the grid.

The South Australian government's \$50 million Grid Scale Storage Fund was designed to facilitate the development of new storage technologies capable of addressing the intermittency of South Australia's electricity system. This fund has supported both large batteries and home batteries operating as a grid-scale asset. Neoen was granted \$15 million from the fund to expand the Hornsdale Power Reserve by an additional 50 megawatts (MW) / 64.5 megawatt-hours of capacity. The expanded facility enables more capacity to respond to system disturbances and to assist in stabilising the grid, and demonstrate for the first time in Australia the provision of battery powered inertia response, which is expected to be critical in safely running a power system with increasing lower levels of fossil fuel generators. An expansion of the South Australian Virtual Power Plant has also been supported from the fund, by up to \$10 million in exchange for providing new grid security benefits to the state. This expansion will see energy systems installed on an additional 3,000 Housing SA properties taking the total participating households to 4,100. In addition, to expand the reach of battery programs, a trial is currently underway of installing batteries without solar systems, which may open up the market for batteries to more residential settings.

The South Australian government is aware of a small number of trials of 'community batteries' in suburban locations. However, their business case in South Australia is yet to be proven. At this time, the market is investing strongly in grid-scale batteries such as the 250MW Torrens Island Battery proposed by AGL and residential and commercial batteries and virtual power plants, which can provide similar grid support. The South Australian government, along with SA Power Networks and other stakeholders, continue to monitor these trials.

There has been an increase in the installation rate of rooftop solar in South Australia since new technical standards commenced in September 2020. This demonstrates continued consumer confidence in rooftop solar and acceptance of the standards brought in to protect the power system from blackouts. Without these new standards and the delivery of the SA-NSW Interconnector, Project EnergyConnect, the expert advice from the Australian Energy Market Operator outlined that a moratorium on new rooftop solar would have been required.

The Liquor and Gambling Commissioner was advised by AUSTRAC of its intention to commence a formal enforcement investigation of SkyCity Adelaide, prior to the notice of the investigation being served on SkyCity Adelaide.

On 7 June 2021, SkyCity Entertainment Group Limited, being the parent company of SkyCity Adelaide, made a market disclosure to the ASX and NZX that AUSTRAC had commenced a formal enforcement investigation into SkyCity Adelaide.

The Liquor and Gambling Commissioner will continue to liaise with AUSTRAC as appropriate during its investigation.

ASK WEBSITE

PLANNING AND DESIGN CODE

In reply to the Hon. J.A. DARLEY (10 June 2021).

The Hon. R.I. LUCAS (Treasurer): The Attorney-General has advised:

The ePlanning platform—an Australian first—unites the PlanSA Portal, the online Planning and Design Code (the code), the South Australian Property and Planning Atlas and the electronic Development Application Processing system.

The new electronic development system allows data about development application processes to be captured more conveniently than ever before. All South Australians can now lodge and track development applications online, search property zoning, find an accredited professional, review development rules, make payments, submit information and track major projects and development activity across the state.

Any issues around the time frames for processing planning applications can be monitored on a regular basis, and in turn may then inform improvements to the code or other aspects of the development assessment process.

With any new system, there will be a period of adjustment. The PlanSA portal and code are significant new systems to learn. Over time, stakeholders will become more familiar with these new systems, and applications will continue to take significantly less time to process. Ongoing enhancements to the system and technical amendments to the code will therefore assist in this area.

I am advised that as at 16 June 2021, there are over 12,000 users of the system, and usage is well within system capacity. The most recent average development approval time for deemed-to-satisfy development applications is 3.35 days and performance assessed development applications is 14.9 days (without public notification) and 41.11 days (with public notification). These time frames are all within the statutory requirements.

The most recent figures show that there has already been significant improvement in processing times for all development application processes when compared to the old planning system.

EARLY LEARNING STRATEGY

The first phase of the three-year development and piloting process to increase the reach and schedule of developmental checks for children will involve further scoping and design.

This will include consideration of what information is collected, how it is collected and how it may be shared. This is a critical part of the expansion to ensure all providers are consistently capturing the outcomes of the health checks and they are shared with relevant services.

Confidentiality and appropriate use of information is paramount. It is anticipated that data collected and shared through this initiative would occur under the protections and authority of existing legislation.

INDEPENDENT COMMISSION AGAINST CORRUPTION INVESTIGATION

In reply to the Hon. F. PANGALLO (24 June 2021).

The Hon. R.I. LUCAS (Treasurer): The Attorney-General has advised:

The Attorney-General sought a briefing from the DPP via the chief executive. This is common practice. It would be remiss of the Attorney-General not to keep abreast of issues such as these. In doing so, she is in no way directing or interfering with the independence of the DPP or the separation of powers between the Attorney-General's office and the DPP.

It is a matter of fact that the DPP is reviewing the matter. The DPP looks closely at a ruling of 'no case to answer' with a view to, if appropriate, filing an ex officio information.
